- 3) 08 bottles (in sealed condition) CAPTAIN 60 up country spirit, 600-ml each bottle and value-Rs-75 of each Bottle
- 4) 03 bottles (in sealed condition) Officer's Choice Whisky, 750-ml each bottle and value-Rs-360 of each Bottle
- 5) 02 bottles (in sealed condition) McDowell's No. 1 RUM, 750-ml each bottle and value-Rs-330 of each Bottle
- 6) 18 Empty bottle of Officer's Choice Whisky, 750-ml
- 7) 15 Empty bottle of McDowell's No. 1 RUM, 750-ml
- 8) 87 Empty bottle of DIL SE 80 up country spirit, 600-ml
- 9) 62 Empty bottle of DIL KHUS 80 up country spirit, 600-ml
- 2) Sale proceed of Rs.- 12,200/- (Twelve thousand and two hundred only)

I SI Parikshit Mahato Adra P.S. do here by lodged a complaint against accd. namely Lakhindar Shaw (48 Yrs.) S/O Lt. Baijnath Shaw of Vill- Laldanga PS- Adra Dist- Purulia & shop owner Bachhu Shaw S/O Lt. Baijnath Shaw of Vill- Laldanga PS- Adra Dist- Purulia to the effect that on 12.06.18 at about 18:45 hrs in course of my evening mobile duty I received a telephonic information from a reliable source that Lakhindar Shaw (48 Yrs.) S/O Lt. Baijnath Shaw of Vill- Laldanga PS- Adra Dist- Purulia & shop owner Bachhu Shaw S/O Lt. Baijnath Shaw of Vill- Laldanga PS- Adra Dist- Purulia was stocked Foreign liquor & country spirit illegally and selling the same to hike price for their personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with C/64 Suresh Dutta & C/41 Dinesh Bouri rushed to the spot for raid by Govt. vehicle. At about 19:15 hrs. myself along with force reached at Mama More and hold raid in the Jhupri of Bachhu Shaw found that said Lakhindar Shaw & Bachhu Shaw stocked liquor at his own Jhupri and selling the same to the consumers. Seeing the Police party some persons including shop owner Bachhu Shaw and Lakhindar Shaw tried to flee away but however after a small chase we were able to apprehend Lakhindar Shaw but Bachhu Shaw fled away. I asked Lakhindar Shaw to produced valid License or valid papers of selling liquor but he failed to produced any valid license or documents for possessing /selling the same, So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd. person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accd. Lakhindar Shaw (48 Yrs.) S/O Lt. Baijnath Shaw of Vill- Laldanga PS- Adra Dist- Purulia & the shop owner Bachhu Shaw S/O Lt. Baijnath Shaw of Vill- Laldanga PS- Adra Dist- Purulia and arrange for its investigation.
