Myself, SI Kousik Banerjee, O/C Adra PS do hereby lodge suo-moto FIR against 20/25 unknown persons and the user of Mobile No. 8210697427 to the effect that today (i.e. 24.06.2018) in course of my mobile duty along with force at about 08:35 hrs. while we was near Metyala village under Adra PS, 20/25 unknown persons with flag of BJP stopped my vehicle and started abusing with me by filthy manners and slang languages. They also tried to pull be down from my vehicle and tried to assault me and my accompanying force. They also threatened me that they will kill me and my other officers and force and will put fire on PS building if I take any action against any BJP supporter/follower and if any other party members disturb them. After this shouting sloganeering they left the place at about 10:35 hrs. with slogans like "JAY SRI RAM", "BJP JINDABAD" etc. before calling additional officers and force from PS. Then I again started to perform mobile duty. In course of mobile duty at 10:44 hrs. one unknown person called me over my official Mobile No. 8145500397 from Mobile No. 8210697427and stated that he is BJP leader from Jharkhand state but he hided his name and address. He told me that "KAYA MAJA AYA, YEAH SAB MAINE KARBAYA" and threatened me that he will come at Adra PS tomorrow along with 400/500 people from West Bengal and Jharkhand and will attack the PS. He also threatened me over telephone that he will kill me and my other officers and force and burn the PS along with all government properties if I take any action against any BJP supporter/follower and if any other party members disturb them. Then I started for PS.

As the conspiracy hold by the unknown users of SIM Card No. 8210697427 and the offences comes under the Sections 341/186/353/120B/506/34 of the Indian Penal Code, I do hereby start a specific case after returning at PS vide Adra PS case No. 50/18 Dt. 24.06.18 U/S 143/341/186/353/120B/506/34 IPC against 20/25 unknown miscreants and the unknown users of SIM Card No. 8210697427.
