

Sir,

In producing herewith the accused person namely Sukram Sing Mura (41 yrs) S/O-Nanda Sing Mura of Parsidih, P.S.-Baghmundi, Dist-Purulia along with seized articles 1) 15 (fifteen) sealed bottle of Dil Se Country spirit each bottle contains 600 ml CS, 2) Approx 15 litre of I/D liquor in a white plastic jarican, 3) 6 pcs of empty bottle of Dil Se Country Spirit, 4) 15 pcs of disposable plastic glass and 5) Rs. 85 /- as sale proceed which were seized under proper seizure list duly signed by the witness.

I beg to submit that today on 10/06/18 in between 18:50 hrs to 19.00 hrs a raid was conducted in his Khapra shed adjacent to the house of Sukram Sing Mura (41 yrs) S/O- Nanda Sing Mura of Parsidih, P.S.-Baghmundi, Dist-Purulia acting on a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found the above noted person was keeping/ selling Country Spirit and I/D liquor which were kept in his Khapra shed adjacent to his house at Pasidih Village. On demand he failed to produce any valid documents in respect of stocking & selling of liquor. As such I arrested him U/S- 67 B.E. Act. and also 1) 15 (fifteen) sealed bottle of Dil Se Country spirit each bottle contains 600 ml CS, 2) Approx 15 litre of I/D liquor in a yellow plastic jarican, 3) 6 pcs of empty bottle of Dil Se Country Spirit, 4) 15 pcs of disposable plastic glass and 5) Rs. 85 /- as sale proceed were seized under proper seizure list duly signed by the witness which is enclosed herewith. During arrest the ground of arrest was duly notified, issued arrest memo and handed over a copy of the same to the arrested person. The above noted arrested accused person namely Sukram Sing Mura (41 yrs) S/O- Nanda Sing Mura of Parsidih, P.S.-Baghmundi, Dist-Purulia committed an offence U/S-46(A)(C) B.E. Act, 1909 for unauthorized possession and sell of Country Spirit from his Khapra shed adjacent to his house at Pasidih Village.

Under the fact and circumstances, I therefore pray that a Case U/S- 46(A)(c) of B.E. Act. 1909 may kindly be started against the said accused person namely Sukram Sing Mura (41 yrs) S/O- Nanda Sing Mura of Parsidih, P.S.-Baghmundi, Dist-Purulia and arrange its investigation.
