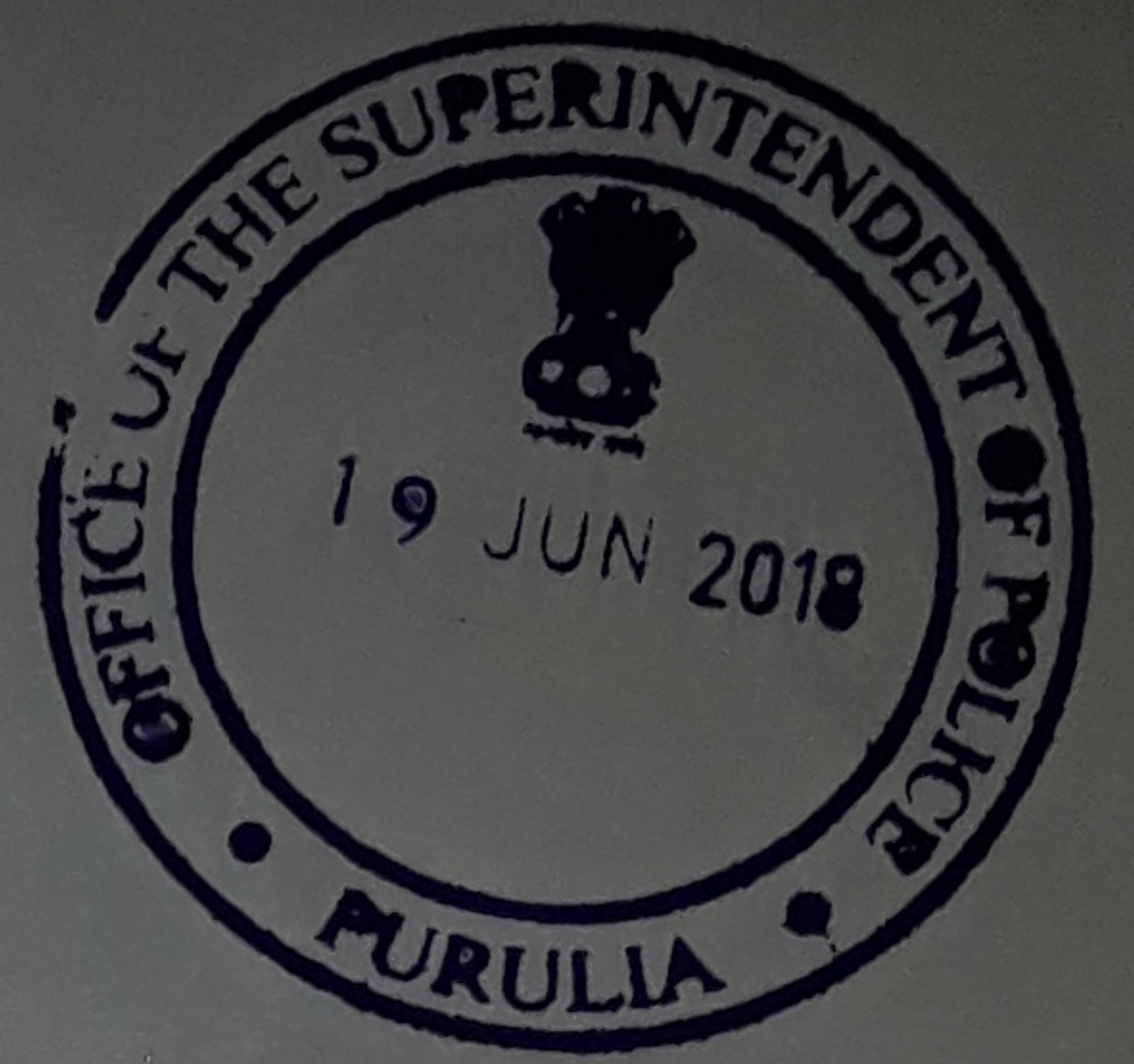

Sir,

I, Sabya Kuiry wife of Netaji Kuiry D/O Pana Kuiry, resident of Village- P.O.- Nowadih, P.S. Bagmundi, Dist. Purulia now residing at my father's house at Village- P.O.- Barendra, P.S. Sonahatu, Dist. Ranchi (Jharkhand) beg to inform you-

That I am the legally married wife of Netaji Kuiry son of Fatik Chandra Kuiry of Village- P.O.- Nowahatu, P.S. Bagmundi, Dist. Purulia.

That marriage in between myself and said Netaji Kuiry was solemnised on 6-6-2017 as per Hindu rites and custom prevalent in our community.

That at the time of marriage my father Pana Kuiry gave Rs. 1,19,000/- to my husband Netaji Kuiry as dowry as per the demand of my husband and his family members.

That my father has also given a HF Delux motor cycle, gold as well as silver ornaments, Palanka, Godrej Almirah, dressing table and utensils to my husband Netaji Kuiry.

That after marriage I went to my matrimonial house at Village - Nowadih and lived with my husband Netaji Kuiry as husband and wife just only for two months and thereafter my husband and his other family members i.e. my father-in-law, mother-in-law, brother-in-law, and my nanad started physical and mental torture upon me.

That my husband Netaji Kuiry assaulted me of and on by fist and blows as well as by lathi and his other family members used abusive and filthy language towards me and they insulted me.

That out of wed-lock in between myself and Netaji Kuiry I became pregnant of 2 1/2 months. But my husband forcibly applied poisonous

substance upon me and forcibly compelled me to drink such poison by pressing my throat and killed the baby of my womb.

That moreso it is submitted that my husband levelled a false allegation in such a manner that I have illegal relation with one Rakesh Kuiry of Village- Nowadih.

That on 28-3-2018 my husband as well as his other family members assaulted me mercilessly by bamboo sticks etc. on my head and body and for that blood profused <sup>from</sup> my head and they have driven out from my matrimonial home of Village- Nowadih and since then I reside at my father's house at Village- Barendra.

That I have informed the matter ~~orally~~ to the police of Suisa out post under Bagmundi P.S. But the police of said out post of Bagmundi P.S. did not take step against my husband and his family members.

Hence I have no other alternative but to submit this written complaint to you for taking necessary action against my husband and his other family members by giving a direction to the O.C. Bagmundi P.S.
