

Sub: Complaint against Sarat Singh Sardar (50 yrs) S/O- Lt. Ananta Singh Sardar of Daldiri, P.S.- Balarampur, Dist. Purulia to start a cog case U/S 147/148/149/323/325/353/427 IPC & 4 PDPP Act.

Respected Sir,

In producing here with one arrested accused person namely Sarat Singh Sardar (50 yrs) S/O- Lt. Ananta Singh Sardar of Daldiri, P.S.- Balarampur, Dist. Purulia along with seized articles 1) 20 pieces Bamboo stick, 2) Some pieces of stone & bricks bat, 3) 15 pieces of Chappal & 4) Some arrows as per attached seizure list, I beg to submit that on yesterday (01.06.18) at 21:35 hrs O/C Balarampur PS received an information over mobile phone that one person namely Dulal Kumar S/O- Lt. Ananta Singh Sardar of Dava, P.S.- Balarampur, Dist. Purulia is found missing from today at about 20:15 hrs. This refers to Balarampur PS GDE No. 35 dt. 01.06.18 after receiving this information O/C Balarampur PS directed me to work out the information accordingly I SI Asoke Kr. Sen along with available Officer & force left PS with Govt. vehicle No. WB56C/4922 to work out the information and this refers to Balarampur PS GDE No. 36 dt. 01.06.18 and C.C. No. 2486 dt. 01.06.18. After arrival at Dava village myself along with other officer & force consulted with the family members of the missing person namely Dulal Kumar and came to learn that on today at about 20:00 hrs. said Dulal Kumar went to supply the dinner of his father at the shop at Dava market but did not return the house till now. Accordingly myself along with force searched the Dava village & surrounding area with the help local villagers to trace out the missing person namely Dulal Kumar but in vain.

On today at about 05:15 hrs we found that one dead body is hanging with a Electrict Hytension Tower near Dava village beside the south side of Balarampur Bugmundih pitch road and the dead body is identified as Dulal Kumar by his family members. Thereafter we cordoned the surrounding area. After receiving this news the local people were assemble there and through abused languages to the Police and obstructed the Police personnel to detach from their duty. There after SI. Prasanta Sau of Balarampur PS prepared surathal report over the dead body of deceased namely Dulal Kumar and send the dead body to Purulia Sadar Hospital Morgue for P.M. examination to ascertain the actual cause of death. Then 500 numbers of local people forming an unlawful assembly under the leader ship Gopal Kataruka and Pradip Sharma both of Balarampur armed with deadly weapon like Lathi, Stone, bow & arrow attacked the Police personnel and throw stone bricks bat arrow aiming to us. As a result more than 15 Police personnel received injury on

their persons and the vehicle No. WB56L/4221 of Dy.S.P. DEB Purulia has been damaged. Somehow I SI. Asoke Kr. Sen arrested one person namely Sarat Singh Sardar S/O- Lt. Ananta Singh Sardar of Daldiri, P.S.- Balarampur, Dist. Purulia after observing all the formalities regarding arrest. Then I seized 1) 20 pieces Bamboo stick, 2) Some pieces of stone & bricks bat, 3) 15 pieces of Chappal & 4) Some arrows as per attached seizure list.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 147/148/149/323/325/353/427 IPC & 4 PDPP Act against the above noted persons and arrange for its investigation.
