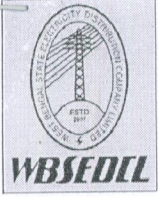

for Unauthorized use of electricity by way of bypassing the Energy Meter
u/s 135 (i) (a), (i) (c) of electricity Act 2003 (Amended in 2007)

Sir,

I Sri Amitava Choudhury, S/O Lt. Sajal Kr. Choudhury, DE & Station Manager, of Balarampur CCC of WBSEDCL do hereby lodge complaint against Amin Mahato, S/O Lt. Mansukh Mahato resides at VIA-Dhebridi, P.O. - Biraudih, P.C. - Balarampur, Dist. - Purulia to the effect that received an information that the aforesaid accused person is committing theft of electricity in his residence by way of tapping the incoming service cable to bypass the proper registration of units in Energy Meter of WBSEDCL.

Acting upon such information today on 05.06.2018 from 4:00 PM to 4:55 PM I along with Sri Anup Mandal, SAE(E) Balarampur CCC, Sri Arindam Chatterjee, O.E Balarampur CCC and other technical persons of Balarampur CCC inspected the premises of Amin Mahato and held raid.

During raid and inspection it was detected that accused Amin Mahato is using electricity dishonestly by way of tapping the incoming service cable to bypass the proper registration of units in Energy Meter of WBSEDCL. Through this bypass arrangement he is using 1 No. Ceiling Fan, 2 Nos 60 Watt Lamp & 1 No 15 Watt CFL having connected load 0.195 kw. The Service Connection of WBSEDCL bearing consumer ID 242167109 stands recorded in the name of the Accused, which has been disconnected on spot upon detection of theft of electricity.

I prepared inspection report in presence of the Accused and assessed the Load as 0.195 kw. Details have been mentioned in the Inspection Report duly signed by the Accused.

I directed the technical persons of M/s. Ajoy Kr. Ghosh (enlisted agency of WBSEDCL) to disconnect the service connection of the above stated Consumer ID. Accordingly they disconnected the aforesaid Service Connection. The Energy Meter bearing SL No 734625, Make- Contimeter, F.R:- 02010.2 installed against the Service Connection was removed from the premises.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence u/s 135(i)(a) & 135(i)(e) of Electricity Act 2003 (Amended in 2007)

Kindly treat this complaint as FIR and take necessary action against the accused.
