I do here by lodge complaint producing the following seized articles (1) 22 bags of fortified Atta each bag weighing 49 Kg and such fortified Atta packed in plastic packet marked as "পশ্চিমবঙ্গ সরকার খাদ্য ও সরবরাহ বিভাগ ভিটামিন যুক্ত আটা " contains 750 gm. (2) One bag wheat weighing 40 Kg. (3) One vehicle having Regn. No. WB-55/5265 (Tata ACE) (Sl. No. 1 & 2 was loaded in Sl. No. 3) to the effect that today (12/06/18) received a credible source information that a vehicle bearing Reg. No. WB-55/5265 loaded with P.D.S articles like fortified Atta and wheat coming from Dhadka side will go towards Jharkhand for clandestine business purpose. Accordingly I noted the fact in G.D vide Bandwan PS GDE No. 521, Dtd-12/06/18 at 09:45 hrs myself along with officer and force of DEB (1) SI Sajal Mishra (2) WC/88 Prodyut Kr. Mondal (3) HG-1427 Benimadhab Char and ASI Subrata Patra of Bandwan PS left for Dhadka village. After arriving at Dhadka village at 10:15 hrs we waited there near Dhadka Anchalik High School for the vehicle bearing Reg. No. WB-55/5265. After waiting sometimes myself found that the said vehicle bearing Reg. No. WB-55/5265 coming there in high speed we give signals to stop the vehicle (WB-55/5265) but the driver disobeying the signal forwarded in front to some extent and stopping the vehicle, the driver fled away. Then myself search for the driver in surrounding area and also wait for him if he come but he did not turn up. In the mean time pickup two local independent witnesses namely 1. Debu Rajak S/O- Lt Ludhu Rajak and 2. Sunil Pramanik S/O-Bharat Pramanik both of Dhadka PS- Bandwan for help us searching the apprehended vehicle. Later in presence of witnesses we searched the vehicle thoroughly and the vehicle was loaded with PDS articles like fortified Atta & wheat. We called Sri Biswanath Agarwal S/O-Lt. Ramswarup Agarwal of Vill+PS-Bandwan, Dist-Purulia local M.R distributor through messenger for help us in weighment of the PDS articles, with help of him we made weighment chart of PDS articles and also seized those articles under proper seizure list in presence of witnesses (1) 22 bags of fortified Atta each bag weighing 49 Kg and such fortified Atta packed in plastic packet marked as "পশ্চিমবঙ্গ সরকার খাদ্য ও সরবরাহ বিভাগ ভিটামিন যুক্ত আটা " contains 750 gm. (2) One bag wheat weighing 40 Kg. (3) One vehicle having Regn. No. WB-55/5265 (Tata ACE) between 12:25 hrs to 12:45 hrs. It is reasonable to believe that the driver in connivance with some others made conspiracy to sell the PDS goods in open market at high price depriving the poor's and needy card holders of BPL & AAY.


Hence the said driver of the vehicle No. WB-55/5265 committed an offence punishable U/S-7(i) (a) (ii) of E.C Act. 1955 for violating the provisions as mentioned in Government Notification No. 2347-FS/Sectt/Food/4P-09/2012, Dtd-08/08/2013 under the West Bengal Public Distribution system (Maintenance & Control) order, 2013.

Hence I request you to start a case U/S-7(i) (a) (ii) of E.C Act. 1955 against the accused driver.
