Most respectfully begs to state :-

1. That the Complainant is the legally married wife of accused No.1, Amalendu Tudu and their marriage was solemnized on 05.07.2012 at Village Batkamkacha, P.S. Nimdih, District Seraikella, Jharkhand accordint to all rites and customs prevailing in Santal Community.
2. That after marriage the Complainant had been to the house of accused No.1 at Village Beldih, P.S. Barabazar District Purulia and started to live as husband and wife.
3. That at the time of marriage the father of the Complainant gave golden and silver ornaments, furnitures, utensils and other articles as dowry but did not give any cash.
4. That after marriage of few months the Complainant was treated well by all the accused persons but thereafter

all the accused persons asked the Complainant to bring a sum of Rs.50,000/- (Rupees fifty thousand) from her father as further dowry of the marriage.

5. That the complainant requested her father to give the amount demanded by the accused persons but her father could not pay the same as he is a very poor man.

6. That when the father of the Complainant expressed his disability to fulfill the demand, all the accused persons started to torture the Petitioner both mentally and physically. They did not give ~~her~~ ^{her} proper food and always used to abuse her. The accused No.1 did not talk with her and allow her to sleep in same room and forced her to sleep in other room. The complainant requested the in-laws not to behave in such unhuman manner but they did not pay any heed to the request, moreover they disclosed that they will give marriage of accused No.1 for the second time.

7. That bearing all such tortures the Complainant stayed in the house of the accused persons with a hope of bright future but one day in the middle of November-2015 all the accused persons assaulted and drove away the complainant from their house, then the complainant informed her father by Telephone. Her father came and took

her to her father's house.

8. That thereafter several times her father took her to the house of the accused persons but they refused to keep her in their house.

9. That lastly on 5.3.2018 at about 10/11 A.M. the Complainant, her father and others went to the house of the accused persons, then her in-laws and accused No.4 Ardhendu Tudu bolted the door from inside and did not allow them enter in their house. They also abused them with various filthy languages and threatened of assault.

10. That thus the Complainant informed the matter at Barabazar Police Station but Police refused to take any action against the accused persons.

11. That then the Complainant lodged Complaint in the Office of the Superintendent of Police, Purulia on 7.3.2018.

12. That uptill now the Police has not taken any step against the accused persons and hence this Complaint.

13. That the accused persons have committed several Offences under the Indian Penal Code for which they are liable to be punished.
