I do hereby lodge complaint, empowered by enabling "The Electricity Act , 2003 "subsequently electricity act-2007 , to the effect that Shri SUSANTA MAHATO S/O AMBUJ MAHATO OF VILL-SHIYARKETYA, P.S- BARABAZAR, DIST- PURULIA, was enjoying electricity unauthorizedly by direct hooking from nearest LT OH Line with the help of 2 core flexible wire and he has committed theft of electricity U/S 135(1)/a of the electricity (Amendment act-2007).

On 14.06.2018 I, Sri ANSHUMAN MITRA, A.E & S.M., BARABAZAR CCC along with

- (1) AMIT SING, SAE(E), BARABAZAR CCC , WBSEDCL
- (2) SAHEB SUTRADHAR, SAE(E), BARABAZAR CCC, WBSEDCL

Entered into the premises of SUSANTA MAHATO S/O AMBUJ MAHATO OF VILL-SHIYARKETYA, P.S- BARABAZAR, DIST- PURULIA and inspected his premises at 05:06 p.m..

During inspection, it was found that SUSANTA MAHATO S/O AMBUJ MAHATO OF VILL-SHIYARKETYA, P.S- BARABAZAR, DIST- PURULIA was enjoying electricity illegally by direct hooking from nearest LT OH Line with the help of 2 core flexible wire having connected load of 0.117 KVA.

From the above arrangement he was using the following equipment:

01. 01 no Electric Bulb(100 watt)
02. 2 core flexible wire(approx. 18m)

Out of which I seized the following articles:

01. . 01 no Electric Bulb(100 watt)
02. 2 core flexible wire(approx. 18m)

Seizure list was prepared at site and accused person refused to sign. After process of inspection and seizure list we left the premises at about 5:16 p.m .

The said person has committed an offence U/S 135(1)/a of electricity act 2003 subsequently electricity (Amendment) act-2007.
