This is to inform you that I, Umang Sah, s/o - Ramesh Kumar Sah of Barabazar, Barabhum, Dist. - Purulia - 723127 is a Reg. Owner of the vehicle bearing Reg. No. - J.H.05 B.S.3377, white colour Bolero ZLX. That on 26.03.2018, one of our business friend namely, S. Suresh Kumar, s/o (unknown) of 3/237, veeram kadu Gaundipalajam, Tokkaradi, P.O.- 637215, Tiruchengade T.K Namakkal, Dist. - Tamilnadu, came to my house at Barabazar and approached my father to take my said vehicle for seven days for urgent basis. Accordingly my father after taking my consent and gave my vehicle to him for goodfaith. Be it further mentioned that we have good business relationship from last two years. But the said Mr. S. Suresh Kumar does not return my vehicle after seven days and several times and along with my father tried to contact him over telephone, but no positive response has not been come out for returning my vehicle. I am waiting till date for receiving my vehicle from him but now I feel that the said person with a criminal intention, my vehicle with the help of our good relationship. That the said S. Suresh Kumar is a owner of S.C.N.S Tube-wells, Bore-well, Drilling Contractor and since 26.03.2018 my vehicle is not in my control.

So necessary legal action may kindly be taken against him as early as possible for such kind of criminal breach of trust.
