Sir,

I, SI Dhirendranath Mandal of DEB, Purulia in producing herewith one Biswanath Gorai (64 Yrs) S/o Lt. Kalipada Gorai of Jabarrah, PS- Hura, Dist- Purulia with seized articles approx 95 Ltrs. of K. Oil containing in 08 numbers of plastic jerricans (Small & big size) loaded with (TVS XL 100) M/C with proper seizure list do hereby lodged a written complaint with relevant papers to the effect that in pursuance a credible source information being directed by Dy.S.P. (DEB), Purulia myself with i) ASI Swapan Chakraborty, ii) HG/1427 Beni Madhab Char all of DEB, Purulia had been to Bhelagora village under Hura PS, Dist- Purulia to work out the received information after noting the fact vide Hura PS GDE No- 1046 Dtd- 26.06.18 that one person will carry K. Oil (PDS articles) from Bhelagora village for clandestine business purpose with a view to earn money by illegal way.

Today (26.06.18) at about 14.05 hrs. arrived near Bhelagora Pry. School, to work out the information and myself with force waiting some times, and observed at 14.20 hrs. the above noted Motor Cycle loaded with K. Oil in jerricans was proceeding from Bhelagora village side through village Kancha Road. I managed to detain the Motor Cycle loaded with K. Oil as noted above. On asking the rider of the Motor Cycle, he disclosed his identity as Biswanath Gorai (64 Yrs) S/o Lt. Kalipada Gorai of Jabarrah, PS- Hura, Dist- Purulia, but failed to produce any valid documents/ papers in respect of loaded above K. Oil. On being asked the offending person Biswanath Gorai stated that he procured this K. Oil from one Mahadeb Mandal (Ration dealer of Bhelagora village) s/o Lt. Gour Mandal of Vill-Bhelagora, PS- Hura, Dist- Purulia. Hence, there is sufficient reason to believe that the above noted accused person making connivance with the above M.R. Dealer procured the above K. Oil by illegal means and carrying the same for clandestine business with a view to earn money by illegal way, depriving the genuine poor Ration Card holder.

Accordingly I, seized the above noted Motor Cycle loaded with K. Oil approx 95 Ltrs. in 08 Jerricans from his possession with proper seizure list duly signed by the accompanied officers & forces as there was no any public witness at the time of seizure and arrested the accused after maintaining all legal formalities regarding arrest after informing him grounds of arrest.

Therefore I, pray kindly start a case u/s- 7(i)(a)(ii) of E.C. Act. x/1955 and 120B IPC for violation of West Bengal Kerosene Control Order 1968. As per order of Dy.SP (DEB), Purulia SI Sajal Mishra of DEB, Purulia will investigate the case.
