I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Santosh Kumar, S/O- Lt. Dukhu Kumar of village- Uparkahan, P.S- Joypur, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 14.06.2018 at about 3.40 PM I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 1. Ganesh Mahato, Gr1 TSH 2. Shibaram Mahato, HG.TSH, entered the premises of Santosh Kumar, S/O- Lt. Dukhu Kumar of village Uparkahan, P.S- Joypur, Dist- Purulia and found Santosh Kumar was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC cable black colour wire by means direct hooking to his house premises and connected load found 0.588 KVA. As Santosh Kumar, S/O- Lt. Dukhu Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Ganesh Mahato, Gr1 TSH 2. Shibaram Mahato, HG.TSH. The inspection team left the premises at 4.05PM.
