I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Chotababu Sadagar, S/O- Sarphu Sadagar of village-Chirkamu, P.S-Joypur, Dist- Purulia has committed theft of electricity U/S 135(1) (b) of electricity act 2003 subsequently amendment act 2007.

On 14.06.2018 at about 2.35 PM I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 1. Ganesh Mahato, Gr1 TSH 2. Shibaram Mahato, HG.TSH entered the premises of Chotababu Sadagar, S/O-Sarphu Sadagar of village-Chirkamu, P.S- Joypur, Dist- Purulia and found Chotababu Sadagar was enjoying electricity unauthorizedly drawing power from incoming service line of WBSEDCL through Cu cable black colour wire by means meter bypassing to his house premises and connected load found 1.144 KVA. As Chotababu Sadagar S/O- Sarphu Sadagar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Ganesh Mahato, Gr1 TSH 2. Sri Shibaram Mahato, HG TSH The inspection team left the premises at 2.55 PM.
