

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Dist.-Purulia Electricity U/S-135(1)(a Electricity (Amendment) Act-2007 to the effect that Sri Kishore Modak S/o Late Debu Modak, Vill-Gamarkuri, PO-Gamarkuri, PS- Kashipur, Dist- Purulia has committed theft of electricity by means of tapping from service cable.

On dated 06.06.2018 I received a secret complain over telephone that Sri Kishore Modak S/o Late Debu Modak, Vill-Gamarkuri, PO-Gamarkuri PS- Kashipur, Dist-PURULIA consuming electricity by means of tapping from service cable of WBSEDCL.

On the basis of said complaint at about 12.35 p.m. I, Sri MrinalChowdhury, Assistant Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with, S&LP wing of RM, office, Purulia and

3)Sri Pradip Modak, SR. TSH, Kashipur CCC

Entered the premises of Sri Kishore Modak S/o Late Debu Modak, Vill-Gamarkuri, PO-Gamarkuri and found that there is meter vide consumer no-242044745 but he is consuming electricity dishonestly by means of tapping from service cable before entering the meter of WBSEDCL.

Total Load found approx 0.30 KW (Fan-2 Bulb-3)

Then we disconnect his hooking line seized the following articles.

- 1)Tapping point of service ---- 12 feet.
- 2) Bulb with holder---1no

After preparation of proper seizure list. The seizure lists are prepared at the site and the representative of accused person refuse to sign in the seizer list. The inspection team left the above premises at about 12.55 P.M.

The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
