The above named complainant begs to state as follows -

That the complainant named above resident of Vill. - Dhanera, P.O. - Gamarkuri, P.S. - Kashipur, Dist. - Purulia (W.B.)

That the complainant is running a business of paddy. He is selling paddy. The foresaid business is situated at Vill. - Dhanera, P.O. - Gamarkuri, P.S. - Kashipur, Dist. - Purulia (W.B.)

3. That the complainant sold paddy to Bhabataran Karmakar of Arndiha, P.S. - Kashipur, Dist. - Purulia in between 05/03/2018 to 12/03/2018 weighing 300 (Three Hundred) quintals and amounting to Rs. 4,18,500.00 (Four Lakh Eighteen Thousand amount to me within 7 (Seven) days.

That on 14/03/2018 Bhabataran Karmakar came again to purchase paddy from me with a vehicle (Truck being No. WB411H-4669) then I requested him to clear his dues i.e. Rs. 4,18,500.00 at that time he assured me to pay the amount within a few minutes.

That after that he fled away from the spot leaving the aforesaid vehicle. I went to his home at Arndiha then I found the home under lock and key and I came to know from the neighbouring persons that he fled away from his house with all his family members.

That the owner of the said vehicle is Golam Ahmad of Paraj (Gohsi), P.S. - Gohsi, Dist. - Bardwan (W.B.).

That the complainant went to Kashipur Police Station and lodged a written complaint regarding all the aforesaid fact to the Officer-In-Charge Kashipur Police Station. The complainant waited for several days and when the police did not take any step regarding the complainant went to Kashipur Police Station for seeking information regarding the aforesaid complainant when the Police Officer advised the complainant to take shelter before the Court. Hence this delay.

The complainant has suffered financial loss of Rs. 4,18,500.00 due to occurrence.

The accused persons has committed an offence which is punishable U/Sec. 420 P.C.

It is therefore prayed that your Honours would be graciously pleased to pass necessary order to send this petition complainant to the Officer-In-Charge Kashipur P.S. U/Sec. 156 (3) Cr. P.C. treating the same as First Information Report and to investigate the same.
