Respected Sir,

In producing herewith one accd. person namely Haradhan Orang (57 Yrs) S/O Lt Sakhichand Orang of village – Karumama, P.S. – Kotshila Dist – Purulia with seizure of 60 (Sixty) sealed bottles of 80° up country spirit “DIL DIMOND” containing 600ml each & @ Rs/- 35 of each bottle & 35 (thirty five) sealed bottle of 80° up country sprit “DIL KHUS” containing 600ml each & @ Rs/- 35 of each bottle.

I beg to submit that today (24.06.18) in between 20.05 hrs to 20.45 hrs a raid was conducted in the grocery shop of Haradhan Orang S/O Lt Sakhichand Orang of village – Karumama, P.S. – Kotshila Dist – Purulia. In course of my evening mobile duty on acting of secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling country spirit which was kept in his grocery shop. On demand he failed to produce any valid document of concern authority in respect of selling/keeping of liquor at that anticipated place . He was committing such illegal act in presence of police person. As such he was arrested u/s-67 B.E., Act. Then I seized 60 (Sixty) sealed bottles of 80° up country spirit “DIL DIMOND” containing 600ml & @ Rs/- 35 each total value of Rs 60X35=2100/- & 35 (Thirty five) sealed bottles of 80° up country spirit “DIL KHUS” containing 600ml each & @ Rs/- 35 each total value of Rs 35X35=1225/- which was seized under proper seizure list in presence of witnesses duly signed by the accused person u/s- 67 B.E. Act which enclose herewith out of 60 (Sixty) & 35 (thirty five) sealed bottles two (600ml) sealed bottle taken out as sample with sealed & labeled. During arrest the ground of arrest was duly notified to the accd. Person and issuing arrest memo u/s- 50 Cr.P.C. and a copy of the arrest memo handed over to the accd. Person .

The above noted arrested accd. namely Haradhan Orang S/O Lt Sakhichand Orang of village – Karumama, P.S. – Kotshila Dist – Purulia, committed offence u/s- 46A (c) BE Act 1909 for un- authorized possession and selling of country spirit from his grocery shop.

It may note here that during raid (01) C/128 Dinabandhu Kumar (02) JC/ 779 Santanu Singha Mahapatra accompanied me vide CC No- 2471/18

Under the fact and circumstance I therefore pray a case u/s 46A (c) B.E. Act. 1909 may kindly be started against Haradhan Orang S/O Lt Sakhichand Orang of village – Karumama, P.S. – Kotshila Dist – Purulia
