



  - That on the date of ofcurance i.e. on 31.3.2018 at about 3 P.M. while the Complainant was working at her kitchen room at that time all them accused persons named above being armed with deadly weapons like Tangi etc. forming an unlawful assembly forcibly and illegally entered into the house of the complainant and they started to abuse the complainant in filthly languages. Thereafter the accused persons also forcibly caught hold the nack of the Complai--nant and they a started to assault the Complainant by firsts and blows . The complainant raised alarm by saying Banchao, Banchao. Hearing the noises the witnesses No.2 Chhaku Bauri came to the spot and saved the Complainant from the hands of the accused persons, then accused Labu Bauri assaulted the husband of the Complainant, namely Chhaku Bauri by Lathi on his head and as a result of which Chhaku Barri sustained vrdevous bleeding indiry on his head. Thereafter the witness No. 7 Bachan Bauri came to the spot to save his parents from the hands of the accused persons, but the accused persons also assaulted Bachan Bauri by Lathi on his head and as a result of which Bachan Bauri also sustained injury on his head. Thereafter all the accused persons took away two numbers of silger chains, golden ear rings and some utensils from the house of the Complainant. The Complainant sustained loss of Rs.30.000/-. The witnesses named above saw the incident and the matter was also reported to them.
