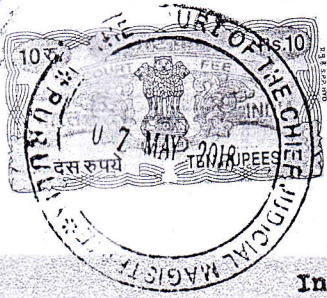

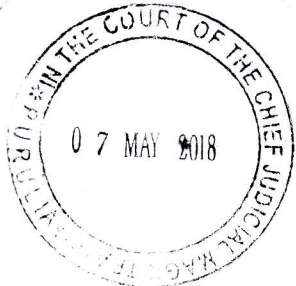

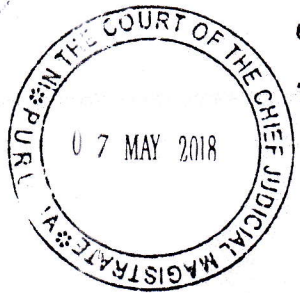

The Complainant above named begs to state as follows :-

1. That the Complainant and the accused persons are the residents of Village Madhupur, under P.S. Manbazar District Purulia and within the jurisdiction of this Learned Court.
2. That on the date of occurrence i.e. on 31.3.2018 at about 3 P.M. while the Complainant was working at her kitchen room at that time all these accused persons named above being armed with deadly weapons like Tangi etc. forming an unlawful assembly forcibly and illegally entered into the house of the complainant and they started to abuse the complainant in filthy languages. Hearing this the Complainant raised objection against the illegal activities of the accused person, then accused No. 1 Withun Bauri assaulted the Complainant by Lathi on her

head and as a result of which the Complainant sustained grievous head injury on her head and and huge blood was oazing out from her head injury. Thereafter the accused persons also forcibly caught hold the neck of the Complainant and they started to assault the Complainant by fists and blows. The complainant raised alarm by saying Banchao, Banchao. Hearing the noises the witnesses No.2 Chhaku Bauri came to the spot and saved the Complainant from the hands of the accused persons, then accused Labu Bauri assaulted the husband of the Complainant, namely Chhaku Bauri by Lathi on his head and as a result of which Chhaku Bauri sustained vrievious bleeding injiry on his head. Thereafter the witness No. 7 Bachan Bauri came to the spot to save his parents from the hands of the accused persons, but the accused persons also assaulted Bachan Bauri by Lathi on his head and as a result of which Bachan Bauri also sustained injury on his head. Thereafter all the accused persons took away two numbers of silger chains, golden ear rings and some utensils from the house of the Complainant. The Complainant sustained loss of Rs.30,000/-. The witnesses named above saw the incident and the matter was also reported to them.

3. That thereafter the Complainant and witness Nos. 2 and 7 went to Menbazar Rural Hospital for their treatment

where they were treated as ^{an} indoor patient. The complainant also reported the matter to the Officer-in-charge, Manbazar P.S. but Police did not take any steps against the accused persons till today. The Complainant also reported the matter to the Superintendent of Police, Purulia on 11.4.2018 but till now police did not take any steps against the accused persons. So the Complainant has been compelled to take shelter before your Honour's Court.

4. That the complainant is a poor woman and she has got no capacity to pull the case on a Complaint basis case and there is question of search and seizure so for the ends of justice the Police case is desirable.

It is, therefore, prayed that your Honour may be pleased to send this petition of complaint before the Officer-in-charge, Manbazar P.S. to treating the same as F.I.R. and to investigate the case as provided Under Section 156(3) Cr.P.C.
