Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. Person namely Karttick Mondal (35) S/O- Lt. Krishna Pada Mondal of village Puapur, PS-Neturia, District- Purulia with seizure of (1) 08 pcs. Sealed bottles of Captain Country spirit containing 600 ml. each (2) 10 pcs. Sealed bottles of Dil Se country spirit containing 600 ml. each (3) 8 Pcs. Of sealed bottles of Dil Se country spirit containing 300 ml each, which were seized under proper seizure list.

I beg to submit that today (17.06.18) in between 20.05 hrs to 21.45 hrs. a raid was conducted in the shop of Karttick Mondal (35) S/O- Lt. Krishna Pada Mondal of village Puapur, PS-Neturia, District- Purulia situated at near by Chalmara village beside Sarbari Panchet pitch road under PS Neturia on acting of a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling liquor which were kept in his shop on demand Karttick Mondal failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents . As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also (1) 08 pcs. Sealed bottles of Captain Country spirit containing 600 ml. each (2) 10 pcs. Sealed bottles of Dil Se country spirit containing 600 ml. each (3) 8 Pcs. Of sealed bottles of Dil Se country spirit containing 300 ml each which were seized under proper seizure list duly signed by witnesses and labeled at the time of arrest. During arrest the ground of arrest was duly notified issuing arrest memo u/s 50 Cr.P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Karttick Mondal (35) S/O- Lt. Krishna Pada Mondal of village Puapur, PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid 1. C /584 Madhab Chandra Majee, 2. C/ 448 Subhankar Mondal & 3. C/ 382 Bipad Taran Chattarjee all of Neturia PS accompanied me.

Under the fact and circumstances I therefore pray that a specific case may kindly be started against Karttick Mondal (35) S/O- Lt. Krishna Pada Mondal of village Puapur, PS-Neturia, District- Purulia under proper section of law.
