The above-named Complainant begs to state as follows:-

1...That the Complainant is the legally married wife of the accused No.1 Biplab Mahato their marriage was solemnized on 1.5.2014.according to Hindu rites and customs as

prevelent in their community and also by observing all the customs of Hindu social marriage and the said marriage is still subsisting.

2-...That at the time of marriage as per demand of the accused persons, the widow mother of the complainant ,practically by beging with the charity of others and also ny-mortgaging some landed properties paid a cash of Rs ,1,20,000/- (Rupees One lakh twenty thousand) blong with the golden ornaments weighing 4 bhories and silver ornaments weighing 2½ bhories along with other valuable artices but they were not at all happy .They also gave out that the articles given by the mother of the complainant was not branded company and those were very simple, in all respect.

3...That however after marriage I went to my matrimonial house and started to reside there as husband and wife with accused no.1 along with other-in\_laws of the family.

4...That for about 2 months from the marriage the conjugal life was some how well persuded a happy prospurpose matrimonial life to be continued as usual. But also two months all hopes and dreams of the complainant

and other accused persons without any reason or slightest fault of the part of the complainant they are all started all shorts of inhuman physical and mental torture upon the complainant which persestly became untorable of the complainant. However the complainant bearing all such tortured and with great difficulties continued her matrmonial life at her matrimonial house though she was not supplied proper food, clothing even daily necessities.

3...That when such state of thing was going on, one fine morning all the accused persons in a very preplanned manner and with common intension with an ill motive demand of Rs.60,000/-(Rupees Sixty thousand) from the complainant and the mother of complainant to be paid the accused persons contrary to that they will not allow the complainant to stay in their house as further. They also gave out that they will soon arrange 2nd marriage of her husband and will get handsome cash with valuable kinds as he is the only son of the family.

4...That when the illegal demand of the accused persons



was not fulfilled they became very much annoyed and degree of torture in more higher and they all of and on abused the complainant in filthy languages by saying that she is saxing looking very ugly and unfit for their family and that they also suspected the character of the complainant. Once accused no.1 put fire in the shari of the complainant which some how extingsed . It was the daily routine of the accused no.1 to assault the complainant in a druken condition instigated by the other accused persons.

5..That ultimately on 19.12.2017.all the accused persons assaulted the complainant driven out her from their house snatching all the belongings shristidhan and other articles and all those are still under the custody of the accused person., which they perhaps will be mis-appropriated and since thereafter the complainant is residing at her father's place.

6...That the accused persons are very clever andthey suspected that the complainant will file cases against them and to avoid and to save their skin the accused no.1 has filed one matrimonial suit for divorce on some false, baseless, motivated , concocted stories.

7. That the matter was duly informed to the local police station add the Superintendent of Police as well add no legal action yet be taken against them for which this complaint is filed before the Ld. Court
