Sir,

I, Bijay Kar s/o Sri. Manik Kar, a resident of Rishi Nibaran Pally (Purana Ashram Area) Ketika, P.S. Purulia (M) District. Purulia, would like to inform you that yesterday i.e. on 06/06/2018 at about 10:30 P.M. while I was sitting outside my house facing the road running in front of my house all on a sudden 1) Arup Kaibartya S/o. Barun Kaibartya, 2) Meghnath Bauri, 3) S/o. Gopal Bauri, 3) Kuntal Mukherjee S/o. late Tappan Mukherjee, 1 & 2 are residents of Sayer Para, Ketika and No.-3 is the resident of Professor colony, Kalimela, Ketika (near J.K. college), appeared there who all are in highly intoxicated state and started hurling filthy comments in the name of my family. I requested them not to disturb the peace and tranquility of the locality but such a request from my end got them enraged instead and they started assaulting me with fist and blows. Finding no alternative I started shouting as I could not over power them with my one hand (my right hand being amputated earlier). In the midst of such assault Arup Kaibartya aforesaid gave out that I must be killed and he in order to execute the same brought a stone from nearby place and tried to hit me on my head but as I tilted my head the blow with the stone hit my face causing permanent dislocation of one of my teeth and damage to 3 other teeth and sustained bleeding injuries in consequence thereof. During such assault on hearing my shout people of the locality including Majoj Mahato, S/o. Srinibas Mahato, Hira Kar, S/o. Manik Kar, Bikash Rajak S/o. Sri Sahadeb Rajak rushed to the spot when the assailants took to their heels.
