## Subject: Complaint regarding RTA

Sir.

This is to inform you that my father Sri Badal Ch. Mishra, aged about 75 yrs and my son Srayan Misra, aged about 14 yrs, went for evening walk on the 26 th March, 2018 at about 6pm to nearby area along Tata road from my residence. We all reside at U.C.Sinha Street, Nadiha, Purulia, at our own residence.

At about 6.30pm two boys riding in a HONDA(LIVO) Bike, the reg. no. being WB 56 TC DIO6, grey in colour with bluish white stripe over the sit, hit my father over the root of the nose, all on a sudden, probably with the fist of one of the boys, on the Tata Road near Nadiha Durgamandir and gone away without taking any care of him. My father fell on the ground followed by profuse bleeding from the the nose. Immediately the local people took him to the Sadar Hospital, Purulia after informing me over mobile phone, with my son. I rushed to the Sadar Hospital, Purulia after getting the news and found my father in a discriented state of mind with bleeding per nose. He had undergone C.T.Scan of Brain immediately and was diagnosed as a case of Brain injury with air inside the brain with frontal lobe Injury with diffuse axional damage and he was referred to any higher centre for necessary management.

I immediately took him to the Medica Hospital, Jamshedpur with my neighbours and close relatives in Private Ambulance. On the way he developed multiple attacks of convulsion. Meanwhile I came to know that the boys were chased by the local people, grabbed and handed over to the Town PS along with the bike. Since then my father was struggling with life and death for a few days. Finally he has been discharged from the hospital with advice to continue high doses of anti-convulsants. He has lost his memories partially, behaving abnormally from time to time with incoherent talks. Private attendants have been kept for his supervision but they also find it a difficult one.

As my father is still in confused state of mind, I could not put any complaint against those boys for such a dangerous act, till date.

l, therefore, request you to look into the matter as an urgent basis and take necessary legal steps against above mentioned persons for such offence.
