The humble Petition on behalf of the above named complainant;
 Most respectfully sheweth :-

1. That on 14/05/18 at about 10.30 A.M. the above-named complainant was busy in daily house hold duties at that time all on a sudden the accused persons namely Prasenjit Majhi S/O Upen Majhi, Biswajit Majhi S/O Upen Majhi, Gour Majhi S/O Lt. Judhistir Majhi, Suvam Majhi S/O Gour Majhi, Arindam Majhi S/O Swapan Majhi, Prakash Majhi S/O Lt. Nripen Majhi, Nitish Majhi S/O Lt. Nripen Majhi, Nitai Majhi S/O Lt. Judhistir Majhi, Swarup Majhi S/O Lt. Deben Majhi, Diptiman Sen S/O Karali Charan Sen, Neha Majhi W/O Nitis Majhi, Jaba Majhi W/O Upen Majhi, all are resident of Vill. Chakda, P.O. Kotlui, P.S. Purulia (M), Dist. Purulia and some other miscreants entered in the house of the complainant with deadly weapons like lathi, iron rod, sword and other sharp cutting weapons due to previous grudge and enmity and started abusive and filthy language towards female folk of the complainant's house and threaten that they will burn the house of the complainant and they will kill them.
2. That thereafter the accused persons mercilessly assaulted the complainant with intention to kill the complainant using lathi, iron rod, sword, stone bricks etc. and the complainant sustained grievous injury on her body.

3. That hearing hue and cry of the complainant the son of the complainant i.e. witness no. 2 namely Ananta Sen and a neighbor i.e. witness no.3 namely Kuber Sen rushed to the house of the complainant. At that time accused persons assaulted Ananta and Kuber by lathi, iron rod, sword, fist and blows. Ananta and Kuber also sustained bleeding injury and they fall down on the earth.
4. That hearing the hue and cry the co-villagers rushed to the house of the complainant and seeing them the accused persons fled away from the house of the complainant.
5. That the co-villagers rescued and shifted the complainant, Ananta and Kuber Sen to Deben Mahato Sadar Hospital, Purulia.
6. That after discharge from the hospital the complainant went before the Purulia (M) P.S. for lodging written complaint but the police personnel refused to lodge any complaint.
7. That thereafter on 29/05/18 the complainant sent a letter to the Superintendent of Police, Purulia in the self same incident but no specific case has yet been started against the accused persons. So, the complainant compelled to file this petition before your Honour's Court for proper justice and to treat this petition as an F.I.R.

It is therefore, prayed that your Honour will graciously be pleased to forward the instant petition of complaint to the Officer-in-Charge of Purulia (M) P.S. with a direction upon him to cause investigation into the case U/S 156(3) Cr.P.C. and further be pleased to pass necessary orders as your Honour deem fit and proper.
