
On behalf of DVC Management, FIR against M/s BLA Projects Pvt. Ltd., Indicon Viva 3rd Floor, 53 A Leela Roy Sarani, Garia Hat Road, Kolkata – 700019 is considered for lodging as under:

1. An ARC was awarded to M/s BLA Projects Pvt. Ltd., Kolkata vide No. 2017-18/552760 dtd. 23-03-2018 for transportation of coal in RCR mode by using Chourasi Railway Siding to Raghunathpur TPS unloading point (copy enclosed).
2. On 02-06-2018, three dumpers (WB 37B – 2824, Wb 76A – 2097 and WB 37D – 5086) were caught red handed while dumping contaminated coal at unloading point of RTPS. All three dumpers were almost full of extraneous materials other than coal. Statement of dumper drivers has been recorded (copy enclosed). Accordingly an FIR was also lodged on 03/06/18 at Raghunathpur Police Station. It is admitted by the concerned drivers that the contaminated coal containing mud & stones was forcefully loaded at Chourasi by the company people. Such corrupt practice was continuing before 2nd June 2018 also.
3. M/s BLA Projects thus violated various provision of contract (Clause No. 2 and 10 (J) under scope of work). It has been noticed that the agency had created a heap of inferior coal mixed with extraneous material with intent of fraudulent and corrupt practices. Instead of ensuring en route surveillance the agency adopted fraudulent practices with ill motive.

In light of the above illegal, corrupt, fraudulent and unwanted activities committed by the M/s BLA Projects, it is requested to kindly register an FIR against the erring agency. Necessary legal action may be taken as per the law of the land.
