Sir,

In producing herewith the arrested accused persons namely (1) Sk Abul Hossain (32 Yrs.) S/o Sk Kasim of Bero Masjid Para, PS - Raghunathpur, Dist.- Purulia and (2) Md. Sanu (22 Yrs.) S/o Md Yunush (Thelawala) of Asansol, Rail Par, Babu Talab, PS - Asansol (N), Dist.- Paschim Bardhaman alongwith seized articles one black colour pistol (Made in Japan) along with 02 Pcs. empty Magazine to the fact that on 22/23.06.18 while I was engaged in night mobile duty on 23.06.18 at 05:15 hrs, received credible source information that one person namely Sk Abul Hossain (32 Yrs.) S/o Sk Kasim of Bero Masjid Para, PS - Raghunathpur, Dist.- Purulia will sold the above noted pistol to some persons at Kalapathar Jangle under Raghunathpur PS.

Accordingly I informed the matter to O/C Raghunathpur PS and as per his direction I along with force left to work out the information. On way I briefed my accompanied force about the above noted matter and the mode of action to be done during detention. At 05:45 hrs. we reached at Kalapathar Jangle under Raghunathpur PS and ambushed ourselves inside the jangle behind some small bushes leaving the Govt. vehicle 300 meters away from Kalapathar Jangle. After few times at about 06:05 hrs, we saw that one person came from Bero side and waiting at Kalapathar Jangle thereafter few minutes at about 06:15 hrs another one person came at Kalapathar Jangle from Ramkanali side and met with each other and whispering with each other. Accordingly we came out from the ambushed point to the spot and disclosing our identity.

On being asked the persons disclosed their name and address as (1) Sk Abul Hossain (32 Yrs.) S/o Sk Kasim of Bero Masjid Para, PS - Raghunathpur, Dist.- Purulia and (2) Md. Sanu (22 Yrs.) S/o Md Yunush (Thelawala) of Asansol, Rail Par, Babu Talab, PS - Asansol (N), Dist.- Paschim Bardhaman but they could not say any satisfactory answer about the presence of their at that time in the spot. On suspicious I along with force searched both the persons and one black colour pistol (Made in Japan) along with 02 Pcs. empty Magazine recovered from the possession of Sk Abul Hossain (32 Yrs.) S/o Sk Kasim of Bero Masjid Para, PS - Raghunathpur, Dist.- Purulia. On interrogation Sk Abul Hossain disclosed before me that he want to sale the above noted pistol and magazine to Md. Sanu (22 Yrs.) S/o Md Yunush (Thelawala) of Asansol, Rail Par, Babu Talab, PS - Asansol (N), Dist.- Paschim Bardhaman. So, Md. Sanu came to the spot to purchase the above noted pistol. On demand Sk Abul Hossain failed to produce any valid document in respect of the above noted pistol and magazine. On interrogation Md Sanu also expressed before me that he came to the spot to purchase the above noted pistol and magazine from Sk Abul Hossain. On further interrogation Sk Abul Hossain stated before me that he also sale fire arms several time to another but he failed to give the particulars the purchaser who will purchased fire arms from him.

As such for committing an offence punishable U/S 25 (1-AA)/27/35 Arms Act. Hence, I arrested the above noted 02 (two) persons after maintaining all formalities of arrest. Then, I seized one black colour pistol (Made in Japan) fire arms along with 02 Pcs. empty Magazine under proper seizure list and proper leveling duly signed by the above noted accused persons and police witnesses. At that time no public witnesses were present at the jangle area.

On return to PS, I lodge a complaint against (1) Sk Abul Hossain (32 Yrs.) S/o Sk Kasim of Bero Masjid Para, PS - Raghunathpur, Dist.- Purulia and (2) Md. Sanu (22 Yrs.) S/o Md Yunush (Thelawala) of Asansol, Rail Par, Babu Talab, PS - Asansol (N), Dist.- Paschim Bardhaman with a prayer to started a case as per law against the above noted 02 persons as well as to arrange for its investigation.
