house without energy registration in WBSRDC energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- ③ TV - 2 (6 hrs)
- ④ CFL - 06
- ⑤ Cooler - 01

- ① PVC wire service cable with tapping arrangement approx. length - 75 FT
