Entered the premises of Mr. L. H. J. Wal Mukherjee, 80 - 1^t Chibhusan Mukherjee, Vill- Rakti bazar, P.S. Santaldihi, Dist- Purulia, having Consumer No. 242052152, Meter No. 750067620 and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(I) (b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- (1) Water Pump - 09
- (2) Electric Fan - 06
- (3) TV - 2 (60w)
- (4) CFL - 06
- (5) Cooler - 01

Out of which I seized the following.

(1) PVC Elec service cable with tapping arrangement app. length - 75 ft

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 2:10 pm on 22/06/18. The accused person has committed an offence U/S135(I) (a) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.
