I would like to lodge the complaint about Solar
Modules cable cut & theft from some unidentified persons
in the plant that we came to know on 10/6/2018; 12/6/2018
at STPS Colony near Kabardhan

The entire plant is divided into two ZONES, ZONE A
& Zone B, A Total of 404 Modules cable cut & theft on
10/6/2018 & 450 modules cable cut & theft on 14/06/2018
and in Zone 'A' area, and a total of 150 modules cables
cut & theft on 12/06/2018 in Zone 'B' area, each solar
modules cable have two type of cables i.e. (Black (Negative)
& Black (Positive) of each 1 mtrs length approximately and is
Copper cable of 4 Sqmm. Also some unknown person throwing stone
on modules & damaged the same. The ^{value} ~~stated~~ properties is approx Rs 20000/-
