Complt most respectfully showeth :-

1. That the complt and the Accd person are well known to each other.
2. That complt is a widow having her two issues one female and another male and female issue namely Rita Chare has attained her age of Majority.
3. That ,complt. has negotiated her daughter's marriage with the help of witness no. 4,5,& 6 who are also well known to the accused persons.
4. That as per the negotiation performance of marriage ceremony was <sup>Scheduled</sup> said to held on 27-4-20=2018 as per rites, customs & usages prevail in the sooty of the complt.
5. That <sup>the</sup> at/time of negotiation complt was under compell circumstance on demand of the Accused persons to accept the same as Bridal article viz 8 vories of gold and cash of Rs. 4 Lac and in pursance of that demand complt finding no other alternative had to pay an amount of Rs. 25\*0,000/- ( out of total demand) as asked by the accd. persons on 12-2-2018 ~~ix~~ in presence of witness 4,5 & 6 Besides the amount Accd persons also having acknowledged two vories of gold ~~chain~~ chain & a ring of gold weighing 1/2 vories left the complt's house on the same day

6. That under Bonafide belief complt was arranging the ~~formal~~ <sup>formal</sup> necessities of her daughter's marriage which was scheduled to be held on 27-4-2018 . But in the mean time Tapas Dey came into the house of the complt on 25-3-2018 and told that his father i.e. Accd No.1 had called to discuss some matter relating to marriage so the complt. and witness No 4 to 6 went to the house of the Accd. persons on 1st April 2018, ~~at the time of Accd person~~ on this Accd. person told the complt asked to pay Rs.10,00000/- (Rs. ten lac) as dowry . But complt stated that as Bridal Gift was fixed as mentioned above as such she was unable to meet the demanded amount ( ten lac) for the purpose of marriage . How ever for the ~~sk~~ sake of daughter's marriage complt surrendered herself with folded hand before Accd. person to consider as she was a helpless widow and for the time being complt returned to her house .

7. That on 25/4/2018 at about 4.30 P.M. Accd No.1 came to the house of the complt asked Rs. 750,000/- immediately as dowry from the complt and also disclosed if the complt would not pay the said amount then the Accd. persons would not accept the daughter to the complt as bride. More so they will not perform the marriage as scheduled to be held on 27-4-18 . Being a helpless lady complt could not provide the amount as such accd. No.1 threatend the complt to face the consequence .

9. That finding no other alternative complt lodge complain with Santuri P.S. but official of Police has not respond to the complt on 26/04/2018 thereafter complt had been to S.P.Purulia for her redressal on 3-5-18 but in vain.

It is therefore prayed that O/C Santuri P.S. may kindly be directed to start investigation into offence committed by the Accd. person after treating this petition as FIR.
