




But in the mean time Tapas Dey came into the house of the complt on 25-3-2018 and told that his father 1.e. Accd No.1 had called to discusss some matter relating to marriage so the complt. and witness No 4 to 6 Went to the house of the Accd. persons on 1st April 2018, at the time of Accd person on this Accd. person told the complt asked to pay Rs. 10,00000/-(Rs. ten lac) as dowry . But complt stated that as Bridal Giftwas fixed as mentioned above as such she was unable to meet the demanded amount (ten lac) for the purpose of marriage . How ever for the wk sake of daughter's marriage complt surrendered herself with folded hand before Accd. person to consider as she was a helples widow and for the time being complt returned to her house .

More so they will not perform the marriage as scheduled to be held on 27-4-18. Being a helplass leady complt could not provide the amount as such accd. No.1 threatend the complt to face the consequence.

arrangements perfouned by the complt went into vain more so . complt became broken heart due to such accet act of the accd persons . Due to such act complt & her unbil daughter became object of question in therir locality due to non performance of marraige.


