Sir,

In producing herewith one arrested accused person namely Sukanta Roy @ Raju (38 yrs) S/O Late Upendra Nath Roy of Vill - Lower Beniasole, Arrabinda Pally, Adra, PS - Adra, Dist- Purulia, A/P in the rented house of Biplab Mandal of Vill- Goruhata, PO+PS- Uluberia, Dist- Howrah along with 1) One country made single shooter improvised pipe gun having length 22 cm (approx), Barrel length 12.5 cm (approx), body length 8 cm (approx) and wooden butt length 9 cm (approx), having barrel, trigger, trigger guard, firing pin, hammer, barrel lock device, appeared to be in working condition, and 2) One round .303 live ammunition which was loaded in the country made single shooter improvised pipe gun as noted in Sl. No. 01 under proper seizure list, I, SI Susanta Kr. Pathak S/O Sri Rabindra Nath Pathak, presently posted at Adra PS, do hereby lodge complaint that, on 04/07/18 at about 00:25 hrs O/C, Adra PS received a source information that one person aged about 35/40 yrs was moving near Samsan Kali Mandir, Lower Beniasole, keeping possession of arms and ammunitions with a motive to commit any cognizable offence at the point of fire arms the information was diarised in General Diary by O/C, Adra PS vide Adra PS GDE No 111 date 04/07/18 and he directed me over telephone to work out the information as I was performing night mobile duty at PS area vide CC No. 1860/18 Dt. 03/07/18. Accordingly myself along with C/-1434 Jagannath Mondal C/- 624 Pradip Chakraborty & IC/-185 Prasanjit Shit had been to "Samsankali Mandir" at Lower Beniasole, Adra at about 01:15 hrs. and watched the person from a distance after concealing ourselves behind a closed shop. I found that a person was moving suspiciously along the road and as the road was lonely at that time so, he was waiting by the side of a banyan tree (at a distance of about 60 mtrs. from the Kali Mandir) in order to commit any crime upon any pedestrian/motorcyclist etc. At the sight of Police the said person took to his heels and after a chase he was caught hold. On interrogation he disclosed his name as stated above. He was asked for his presence in such a lonely place at midnight and he made different statements at different times. Then I offered the said Sukanta Roy @ Raju to search me and my Police party before searching his body, but he refused. Then I searched his body and found one country made single shooter improvised pipe gun which was loaded with one .303 live ammunition at his waist. I demanded for relevant license of document from him in respect of possessing the said fire arms and ammunition, but he failed to produce any such valid documents in respect of possessing the said fire arms and ammunition and could not give nay satisfactory account in this regard which made me to believe that the accused person possessed those fire arms and ammunition illegally for some ulterior motive. So I seized 1) One country made single shooter improvised pipe gun having length 22 cm (approx), Barrel length 12.5 cm (approx), body length 8 cm (approx) and wooden butt length 9 cm (approx), having barrel, trigger, trigger guard, firing pin, hammer, barrel lock device, appeared to be in working condition, and 2) One round .303 live ammunition which was loaded in the country made single shooter improvised pipe gun as noted in Sl. No. 01 from his exclusive possession under proper seizure list duly signed by Police witnesses and also by the accused person. I prepared label for the seized item. Then I arrested the above noted accused person after issuing Memo of Arrest & Inspection Memo and after obtaining all formalities and guidelines as laid by the Apex Court of India, NHRC and WBHRC as he illegally possessed fire arms and live ammunition to use those for unlawful purpose. I tried to collect public witnesses but as it was midnight and the place was lonely, I could not arrange for any public witnesses. Accordingly after returning at PS, I produced the arrested accused along with the seized fire arms and live ammunition with all relevant documents.

Under the above circumstances, I therefore pray that a case may kindly be started under proper sections of law against the arrested accused person Sukanta Roy @ Raju (38 yrs) S/O Late Upendra Nath Roy of Vill - Lower Beniasole, Arrabinda Pally, Adra, PS - Adra, Dist- Purulia, A/P in the rented house of Biplab Mandal of Vill- Goruhata, PO+PS- Uluberia, Dist- Howrah and to arrange for its investigation.
