- 3) Ten pieces of plastic glass.

I ASI Somnath Mahanty Adra P.S. do here by lodged a complaint against accd. namely Biswajit Mondal (21 yrs.) S/O Sujal Mondal of Vill- Gote PS- Saltora Dist- Bankura A/P Vill- Bankradanga PS- Adra Dist- Purulia to the effect that on 10.07.18 at about 18:25 hrs in course of my evening mobile duty I received a telephonic information from a reliable source that one Biswajit Mondal (21 yrs.) S/O Sujal Mondal of Vill- Gote PS- Saltora Dist- Bankura A/P Vill- Bankradanga PS- Adra Dist- Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with C/1284 Pratap Aditya Majhi & C/913 Satyaban Mahato rushed to the spot for raid by Govt. vehicle. At about 18:35 hrs. myself along with force reached at Indira More (Near Muktadal Club) and hold raid in the jhupri of Biswajit Mondal found that said Biswajit Mondal liquor at his own jhupri and seeing the Police party some person fled away and said Biswajit Mondal to concealed himself but we are able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produced any valid license or documents for possessing/selling the same, So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd. person and available witnesses.
