Entered the premises of Nityananda Rakshit, S.O- Manik Rakshit of

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly  
by drawing illegal hooking from the nearest L.T.O.H line of  
W.B.S.E.D.C.L i.e U/S 135 (1)(a) was detected

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.  
one ceiling Fan and one LED light.

Out of which we seized the following:

Single core 2 wire approx 8 mtr flexible cable with hooking device.

The seizure lists are prepared at the site and the accused person signed in the seizer list

The inspection team left the above premises at about 11:05 AM on dated 12-07-2018. The  
accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007.
