 operating electrical apparatus of 2 m from of 100 watt
 each and 3 m bulb. As the theft of electricity
 was detected during inspection by hooking method,
 we disconnected the unauthorised electric line
 and seized the seizure article as taken basis
 in the proper seizure list (enclosed). The local
