Sir,

I, SI Gokul Chandra Ruhidas S/o Ram Pada Ruhidas of Arsha PS in producing herewith seized articles 47 Kgs.800 gram Ganja in two nylon big bags fitted with chain and 04 packets samples each containing 100 grams all are duly labelled & one vehicle made of Renault KWID having Engine no. E105210, Chasis No. MEEBBA007J1562000 do hereby lodged complaint against 1) owner and 2) driver on 12.07.18 and one another co- passenger of the vehicle whose details particulars could not be collected so far to the effect that today i.e. 12.07.18 at about 18:05 hrs while myself along with ASI Chandni Das Chakraborty and force C/628 Giridhari Bouri, C/419 Birapada Singh vide CC No. 1698/18 dated 12.07.18 were performing anti crime petrol duty followed by Naka checking at near Kourang village on Tata-Purulia road under this PS noticed that one vehicle was coming from Tata side and proceeding towards Purulia side along Tata- Purulia road with excessive speed and all on a sudden around 200 meters away from us the vehicle stopped on the road and driver and one co- passenger of the said vehicle ran away inside the Kantadih jungle leaving the vehicle at the same. Accordingly keeping a police personnel by the side of the vehicle we chased them and entered into the jungle. After a thorough and combing search we failed to apprehend them. Finding no other alternative myself along with my party came in front of the vehicle and on being searched two big size nylon bag fitted with chain were found at the back side dickie seat of the vehicle having bad smell. Accordingly I opened the chain of one bag and found full of intoxicated articles seems to be cannabis. Then strong suspicion arises in our mind and I informed O/C Arsha PS over phone requesting him for his appearance with one Executive Magistrate or any Gazetted Officer. At about 19:50 hrs. O/C Arsha PS accompanying BDO Arsha arrived at near Kourang village. Mean while I asked the local villagers to be with us before the arrival of Executive Magistrate and also requested them to remain present during search operation on arrival of Executive Magistrate. In this respect I issued notice to them namely Bullet Mahato and Lakhikanta Hembram and we cordoned the vehicle. After the arrival of O/C Arsha PS and BDO, Arsha I again issued notice to them to search our body before search of the vehicle by us in presence of BDO Arsha. Accordingly a nil seizure list was prepared in presence of BDO Arsha after conducting search by the witnesses to us. Then we searched the vehicle in presence of the witnesses and Executive Magistrate along O/C Arsha PS. On checking of the vehicle we noticed 02 big size nylon bags on the backside of dickie seat of the said vehicle containing full of Ganja (Cannabis). Took some pix of the articles as well as the vehicle. Then I collected measuring / weightment instrument locally and measured each 02 (two) bags of Ganja which containing 23 kg 600 grams, and 24 kgs 200 grams Ganja respectively. Then I collected 03 (three) samples containing 100 grams each from each bag marking each sample as Sample-A1, A2, A3 & B1, B2, B3 in presence of the witnesses and BDO Arsha. Then I have seized the recovered GANJA in 02 (two) bags including samples and involved vehicle made of Renault KWID having Engine no. E105210, Chasis No. MEEBBA007J1562000 in presence of witnesses and Executive Magistrate BDO Arsha after preparing a seizure list which is duly signed as well as by the witnesses as noted above. It is clear that the accused driver and his co partner in full connivance with owner of the vehicle is running such clandestine business since long after collecting the same from Jharkhand side and dispatching the same in high rate at Bokaro side. Hence as they are liable for prosecution under Section 20 (b) (i) / 29 NDPS Act, 1985, so after observing all formalities I therefore submitting a complain before O/C Arsha PS against the above mentioned 03 accused persons with a view to start a specific case against them.

I, therefore, pray before your kind honour to register a case against 1) owner and 2) driver on 12.07.18 of vehicle having Engine no. E105210, Chasis No. MEEBBA007J1562000 and one another co- passenger of the vehicle under Sec. 20 (b) (i) / 29 NDPS Act, 1985 and to arrange for its regular investigation.
