Sir,

In producing herewith the accused person namely Sambhunath Mandal (35 yrs), S/O-Lt-Maheswar Mandal of Vill-Nischintapur, P.S-Baghmundi, Dist-Purulia along with seized articles 1) One plastic packet loaded with ID Liquor (Chullu) approx 11 ltr, 2) One plastic packet loaded with ID Liquor (Chullu) approx 15 ltr, 3) 05 (Five) pcs Plastic Glass, 4) Cash Rs. 135 rupees (One Hundered Thirty Five), which were seized under proper seizure list duly signed by the witness.

I beg to submit that today on 08.07.18 during the special raid I along with 1. C/853 Ranjit Majhi, 2. C/598 Mohan Majhi, all of Baghmundi P.S at 17:45 hrs arrived at Nischintapur village and a raid was conducted in the house of Sambhunath Mandal (35 yrs), S/O-Lt-Maheswar Mandal of Vill-Nischintapur, P.S-Baghmundi, Dist-Purulia, acting on a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found the Sambhunath Mandal (35 yrs), S/O-Lt-Maheswar Mandal of Vill-Nischintapur, P.S-Baghmundi, Dist-Purulia were keeping/ selling Id Liquor (Chullu) which were kept with his possession in his house. On demand he failed to produce any valid document from competent authority in respect of stocking & selling of liquor. As such he was arrested U/S- 67 B.E. Act. And also seized 1) One plastic packet loaded with ID Liquor (Chullu) approx 11 ltr, 2) One plastic packet loaded with ID Liquor (Chullu) approx 15 ltr, 3) 05 (Five) pcs Plastic Glass, 4) Cash Rs. 135 rupees (One Hundered Thirty Five), which were seized under proper seizure list duly signed by the witness U/S- 67 B.E. Act. A sample ID liquor (Chullu) taken out as sample and all seized articles were labeled properly in presences of witness and accused person. Hence I arrested the above noted person. During arrest the ground of arrest was duly notified, issued arrest memo U/S- 50 Cr.P.C and handed over a copy of the same to the arrested person.

The above noted arrested accused person namely, Sambhunath Mandal (35 yrs), S/O-Lt-Maheswar Mandal of Vill-Nischintapur, P.S-Baghmundi, Dist-Purulia committed an offence U/S- 46 A(c) B.E. Act. 1909 for unauthorized possession and selling of Id Liquor (Chullu) and country made ID liquor from his sole possession in his own house.

Under the fact and circumstances I therefore pray before you a specific Case may kindly be started against the said accused person under proper section of law and obliged.
