I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Subarna Lohar S/O- Sri Hari Lohar, P.S- Bagmundi of village Pogrodi, P.O- Burda, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 12-07-18 at about 4.10 Pm I Sri Swapan Kumar Das, AE & Station Manager, Bagmundih CCC along with 1. Sri Sukhamoy Maji, SAE(E) and 2. Abdul Hasib LM 3. — entered the premises of Sri Subarna Lohar, S/O- Sri Hari Lohar of village Pogrodi, P.S- Bagmundi, Dist- Purulia and found Sri Subarna Lohar was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.1 KVA. As Sri Subarna Lohar S/O- Sri Hari Lohar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Sukhamoy Maji SAE(E) and 2. Sri Abdul Hasib LM. The inspection team left the premises at 04.15.
