I Sri Amitava Choudhury, s/o dt. Sajal Kr. Choudhury, DE & Station Manager of Balarampur CCC, WBSEDCL do ~~not~~ hereby lodge complaint against Swapam Mahanty, s/o dt. Gour Ch. Mahanty resides at viii - Kamarpara, Near Bus Stand Balarampur, P.O. Kangadish, P.S. Balarampur, Dist. Purulia to the effect that received an information that the abovesaid accused person is committing theft of electricity in his residence by way of direct hooking from the nearby LTOH line of WBSEDCL.

Acting upon such information today on 02.07.2018 from 3.00 PM to 3.30 PM I along with Sri Anup Mandal, SAE, Sri Manab Kr. Maji, SAE, Sri Arindam Chatterjee, D.E Balarampur CCC and technical persons of M/s Ajay Kr. Ghosh (Enlisted Agency of WBSEDCL) inspected the premises of ~~Swapam Mahanty~~ Swapam Mahanty and held raid.

During raid and inspection it was detected that accused Swapam Mahanty is using electricity dishonestly by making direct hooking from the nearby LTOH line of WBSEDCL for running 2 Nos Ceiling Fan, 1 No Fluorescent Tube, 1 No 100 Watts Lamp & 1 No CFL Lamp (20watts), having total connected Load 0.28 KW.

I prepared inspection report in presence of the representative of the accused and assessed the load as 0.28 kW, details have been mentioned in the inspection report duly signed by the representative of the accused.

I directed the technical persons of M/s. Ajoy Kr. Ghosh to disconnect the hooking arrangement from our LTOH Line. Accordingly they disconnected the aforesaid hooking arrangement from LTOH line.

I prepared seizure list in presence of witnesses, details of seizure have been mentioned in the seizure list and obtained signature of the ^{representative of} accused. A copy of seizure list was handed over to the representative of accused. The local people gathered there witnessed the incident but refused to sign on the seizure list and inspection report.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence up to 135 (i) (a) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
