I Sri Amitava Choudhury, S/O Lt. Sajal Kr. Choudhury, D.E & Station Manager of Balarampur CCC of WBSEDCL do hereby lodge complaint against Kamala Kanta Das S/O Lt. Gopintha Prasad Das resides at vill-Bela, P.O.-Rangadaha, P.S.-Balarampur, Dist.-Purnia, to the effect that received an information that the aforesaid accused person is committing theft of electricity in his residence by way of tapping the incoming service cable to bypass the proper registration of units in Energy Meter of WBSEDCL.

Acting upon such information today on 06.07.2018 from 1.55 pm to 2.45 pm. I along with Sri Anup Mandal, Sri Manabkr Maji both SAE Balarampur CCC along with the technical persons of M/s. Ajoy Kr. Ghosh (enlisted agency of WBSEDCL) and other officials of Balarampur CCC inspected the premises of Kamala Kanta Das and held raid.

During raid and inspection it was detected that accused Kamala Kanta Das is using electricity dishonestly by way of tapping the incoming ~~cable~~ service cable to bypass the proper registration of units in Energy Meter of WBSEDCL. Through this bypass arrangement he is using 1 No Tr, 3 Nos Ceiling Fan & 3 Nos 20watts CFL Lamp having connected load 0.34 kW. The service connection of WBSEDCL bearing Consumer ID 200711757 stands recorded in the name of the Accused, which ~~has~~ has been

disconnected on spot upon detection of theft of electricity.

I prepared inspection report in presence of the <sup>representative</sup> Accused and assessed the load as 0.34 KW. Details have been mentioned in the inspection report and duly signed by the representative of the accused.

I directed the technical persons of M/s. Ajoy Kr. Ghosh (enlisted agency of WBSEDCL) to disconnect the Service Connection of the above stated consumer ID. Accordingly they disconnected the aforesaid service connection.

I prepared seizure list in presence of the witnesses, details of seizure have been mentioned in the seizure list and obtained the signature of the representative of the accused. A copy of seizure list was handed over to the accused. The Local people gathered there witnessed the incident but refused to sign on the seizure list and inspection report.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence u/s 135(i)(a) & 135(i)(c) of Electricity Act 2003 (Amended in 2007)

Kindly treat this complaint as FIR and take necessary action against the accused.
