I Sri Amitava Choudhury, S/O dt. Sajal K. Choudhury, D.E & Station Manager of Balarampur CCC WBSEDCL do hereby lodge complaint against Johan Tudu S/O dt. Shambhu Nath Tudu, resides at vill- Nandudih, P.O- Namsole, Ps. Balarampur Dist- Purulia to the effect that received an information that the aforesaid accused person is committing theft of electricity in his residence by way of hooking from the nearby LTOH line of WBSEDCL to by pass the proper registration of units in energy meter of WBSEDCL.

Acting upon such information today on 11.07.2018 from 4.00 PM to 4.40 PM I along with Sri Anup Mandal, Sri Manab Kumar Maji both SAE of Balarampur CCC and technical persons of M/s. Ajoy K. Ghosh (enlisted agency of WBSEDCL) and other officials of Balarampur CCC inspected the premises of Johan Tudu and held raid.

During raid and inspection it was detected that accused Johan Tudu is using electricity dishonestly by way of ~~tapping~~ hooking from the nearby LTOH line of WBSEDCL to by pass the proper registration of units in Energy Meter of WBSEDCL. Through this hooking arrangement he is using LED Lamp 9 watts - 3 Nos, Ceiling Fan - 3 Nos, 20 watts CFL - 3 Nos, TV - 1 No & Tube Pump 1/2 HP - 1 No having connected load of 0.742 kW. The service connection of WBSEDCL bearing consumer ID 242232145

stands recorded in the name of the Accused which has been disconnected on spot upon detection of theft of electricity.

I prepared inspection report in presence of the Accused and assessed the load as 0.742 kW. Details have been mentioned in the inspection report and duly signed by the accused.

I directed the technical persons of M/s. Ajoy Kr. Ghosh (enlisted agency of WBSEDCL) to disconnect the service connection of the above said Consumer ID accordingly they disconnected the aforesaid service connection.

I prepared seizure list in presence of the witnesses, details of seizure have been mentioned in the seizure list and obtained the signature of the accused. A copy of seizure list was handed over to the accused. The local people gathered their witnessed the incident but refused to sign on the seizure list and inspection report.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence up 135(i)(a) & 135(i)(c) of Electricity Act 2003 (Amended in 2007)

Kindly treat this complaint as FIR and take necessary action against the accused.
