To The Officer-in-Charge Balarampur PS Purulia

I, Sri Tapas Kr. Ghosh, Inspr. of Police, DEB, Purulia, do here by lodge complaint against alleged Daud Ansary s/o Asgar Ansary of Muradgang, near Balarampur bus stand PS Balarampur, Dist Purulia in producing the following seized articles (1) 540 (Five hundred & forty) ltrs. of Kerosene Oil in 12 (twelve) plastic jerricans (big & small) to the effect that today 12.07.18 in persuasion of a secret information regarding clandestine business of kerosene oil, which is being runned by above noted alleged person. Myself along with C/88 Pradyut Mandal, HG/1524 Birendra Nath Hansda & JC/571 Prasenjit Mandal had been to Balarampur PS and noted the information at Balarampur PS at 16:15hrs. vide Balarampur PS GDE No. 553 dtd.12.07.18 and also submit a requisition to OC Balarampur PS for rendering assistance. Thereafter, myself alongwith force left for Muradgang, near Balarampur bus stand under Balarampur PS to work out the information by availing Govt. vehicle. On arriving at Muradgang, near Balarampur bus stand, we identified the house of above noted person and entered into his house.

On searching the said premises we found a huge quantity of Kerosene Oil were stored inside the house and being asked I came to learn from the other house inmates that the house owner Daud Ansary now absent from the house and he is running such clandestine business since long without any valid documents/ licence to earn money by illegal means. As such he stored such huge quantity of kerosene oil. Accordingly I seized (1) 10 (Ten) big plastic jerricans containing each 50 liters of kerosene oil (2) 02 (Two) small plastic jerricans containing each 20 liters of kerosene oil as mentioned in the seizure list in presence of witnesses duly signed by them.

During preliminary enquiry it revel that said Daud Ansary s/o Asgar Ansary of Muradgang, near Balarampur bus stand PS Balarampur, Dist Purulia by his such activities willfully violated the provision of Para 4 of West Bengal kerosene control order 1968 and committing an offence punishable u/s 7(i)(a)(ii) of Act X 1955. It is also to be noted that the Daud Ansary is habituated in dealing with clandestine storage and sold of Kerosene Oil in Black Market with high rate and thereby deprived poor consumers as well as causing loss of revenue to Government. I therefore request you to start a case u/s 7(i) (a) (ii) of Act X/1955 against Daud Ansary s/o Asgar Ansary of Muradgang, near Balarampur bus stand PS Balarampur, Dist Purulia.
