Bit of village Rajgram was enjoying electricity unauthorisely by tapping of service line. Meter No - L402079 consumer no - 242211990.

Has committed theft of electricity U/S 135(4A) of The Electricity Act 2007.

Entered the premises of Arjun Ch. Bit, 40 - Sudip ch. Bit at village Rajgram, and inspect his/her premises. During inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal Tapping Service wire from the nearest L.T.O.H line of WBSEDCL e.i. u/s 135 (1)/(2) was detected.

From the above arrangement he/she was using the following electrical equipments:
