Has committed theft of electricity U/S 135(1)(b) of The Electricity Act 2007. He is present even now. On 24.07.18 at 03:30pm. Sri Ramesh Singh, SM of Bundwan CCC, WBSECL

and inspect his/her premises. During inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal hooking from the nearest L.T.O.H line of WBSECL e.i. u/s 135 (i)/(b) was detected.
