Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act , 2003 "subsequently electricity act-2007 , to the effect that Shri BIBHISAN MAHATO S/O RATHU MAHATO OF VILL-GOHIKOKCHA, P.S- BARABAZAR, DIST- PURULIA, was enjoying electricity unauthorizedly by direct hooking from nearest LT OH line through 2-Core PVC cable and he has committed theft of electricity U/S 135(1)/a of the electricity (Amendment act-2007).

On 17.07.2018 I, Sri ANSHUMAN MITRA, A.E & S.M., BARABAZAR CCC along with

- (1) Saheb Sutradhar, SAE(E), Barabazar CCC, WBSEDCL
- (2) JALAD BARAN GHOSHAL, L.M, Barabazar CCC, WBSEDCL

Entered into the premises of BIBHISAN MAHATO S/O RATHU MAHATO OF VILL-GOHIKOKCHA, P.S- BARABAZAR, DIST- PURULIA , and inspected his Poultry Farm at Gohmikocha at 07:25 p.m.

During inspection, it was found that BIBHISAN MAHATO S/O RATHU MAHATO OF VILL-GOHIKOKCHA, P.S- BARABAZAR, DIST- PURULIA, was enjoying electricity at his Poultry Farm illegally by direct hooking from nearest LT OH line through 2-Core PVC cable in his Poultry Farm at GOHIKOKCHA with connected load of 1.271 KVA.

From the above arrangement he was using the following equipment:

01. 02 no Electric Bulb (200 watt)
02. 10 no of Ceiling Fan (60 watt)
03. 9 no of LED bulb (9 Watt)

Out of which I seized the following articles:

1. 1 no of 2-core PVC Cable (18 mtr. Approx) with hooking device.
2. 1 no Electric Bulb (200 watt).
3. 1 no LED Bulb (9 Watt)

Seizure list was prepared at site and accused person refused to sign. After process of inspection and seizure list we left the premises at about 7:50 p.m.

The said person has committed an offence U/S 135(1)/a of electricity act 2003 subsequently electricity (Amendment) act-2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule. The F.I.R has been delayed Due to extreme weather condition and also the vehicle was breakdown while returning to Barabazar on 17th July 2018.
