Sir,

In producing herewith the accd. Bagdulla Sabar @ Rabi Sabar (36) S/o Lt. Banku Sabar of Bagalbandh, PS-Barabazar, Dist- Purulia who is brought under arrest along with seized articles as per seizure list i.e one improvised country made one shooter iron made pipe gun length approx 12" having wooden butt measuring approx 3.5", iron body measuring approx 3.4", iron made barrel measuring approx 6.6", trigger, firing pin etc and one plastic bag. I SI Hemanta Kr. Sahababu of Barabazar PS do hereby lodge a type complaint against the above noted person to the effect that on 01.07.18 while myself along with C/290 Nezam Uddim Shaikh and C/538 Eashan Prokash Baskey both of SAP 7th Bn. Kalyanpur, Asansol were performing evening mobile duty in the P.S area at that time received an information from secret source that one person was moving on the Barabazar-Sindri pitch road nearby Ballarghat area to Fagudih jungle under Barabazar PS in suspicious manner. After reaching the information I consulted with the I.C Barabazar PS over mobile phone and I have been directed by the I.C Barabazar PS to work out the said information of the secret source. As such myself along with C/290 Nezam Uddim Shaikh and C/538 Eashan Prokash Baskey both of SAP 7th Bn. Kalyanpur, Asansol left to work out the information by Govt. Vehicle having No. WB26K/5475 and reached at there at 20.25 hrs. in a safe distance to the information place and we have seen that one person was standing at Ballar Ghat on the Barabazar-Sindri pitch road nearby Fagudih Jungle for committing any crime upon the ongoing vehicle on Barabazar- Sindri pitch road at any time. Requested to the pedestrians named as Dhananjoy Mahato S/o Lt Gurucharan Mahato of Sargo & Bahadur Mahato S/o Radhanath Mahato of Kadampur both of under Barabazar PS, Dist- Purulia who are willing to present at the time of searching of suspicious persons and they accompanied with us. Accordingly we slowly moved to the information place and found that one person was standing at Ballar Ghat beside Barabazar Sindri pitch road nearby Fagudih jungle. We able to apprehended him and on being suspicious I searched him and found that one improvised country made one shooter iron made pipe gun was kept in a plastic bag on his left hand. On being asked he failed to produce any valid documents in support of carrying / possession such fire arms. On interrogation he disclosed his identity as stated above and made incoherent statement in respect of his presence at that place and also the purpose of possession of fire arms. It is reasonable gourd to believe that he chooses the said alone place pre plainly to commit any grievous offence against vehicle etc. on interrogation he confessed that previously he was involved in many criminal cases in different PSs in Purulia district.

So, finding no any other alternative way and after observing all formalities on the same day at 20.45 hrs and 21.15 hrs I seized the said fire arms from his exclusive possession under proper seizure list in presence of public witnesses as well as Police witnesses duly signed by them. I made over one copy of seizure list to allege person duly signed by him as token acknowledgment and also labeled the same by me. Then I arrested him at 21.55 hrs after observing all formalities regarding arrest u/s 50 Cr.P.C as he is liable for prosecution u/s 25(I) (a)/25(I-A) Arms Act.

Therefore, I pray that a specific case may kindly be started against Bagdulla Sabar @ Rabi Sabar S/o Lt. Banku Sabar of Bagalbandh, PS-Barabazar, Dist-Purulia under proper section of law.
