Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act , 2003 "subsequently electricity act- 2007 , to the effect that Shri SUDIP KARMAKAR, S/O- ARUN KARMAKAR, VILL-SANKHARI, P.S- BARABAZAR, DIST- PURULIA was enjoying electricity unauthorizedly by direct hooking from nearest LT OH line through 2 Core PVC cable and he has committed theft of electricity U/S 135(1)/a of the electricity (Amendment act-2007).

On 25.07.2018 I, Sri ANSHUMAN MITRA, A E & S M., BARABAZAR CCC along with

- (1) Saheb Sutradhar, SAE(E), Barabazar CCC, WBSEDCL
- (2) Chandi Charan Karmakar, C.M, Barabazar CCC, WBSEDCL

Entered into the premises of SUDIP KARMAKAR, S/O- ARUN KARMAKAR, VILL-SANKHARI, P.S- BARABAZAR, DIST- PURULIA and inspected his premises at 08.25 p.m

During inspection, it was found that SUDIP KARMAKAR, S/O- ARUN KARMAKAR, VILL-SANKHARI, P.S- BARABAZAR, DIST- PURULIA was enjoying electricity illegally by direct hooking from nearest LT OH line through 2 Core PVC cable in his premises at Sankhari with connected load of 0.71 KVA (0.071) KVA

From the above arrangement he was using the following equipment:

01. 01 no Electric Bulb (60 watt)

Out of which I seized the following articles:

1. 1 no of PVC Cable (9 mtr. Approx) with hooking device. (Single core)
2. 1 no Electric Bulb (60 watt).

Seizure list was prepared at site and accused person refused to sign. After process of inspection and seizure list we left the premises at about 8.45 p.m.

The said person has committed an offence U/S 135(1)/a of electricity act 2003 subsequently electricity (Amendment) act- 2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule. The F.I.R has been delayed Due to extreme weather condition and also the vehicle was breakdown while returning to Barabazar on 25th July 2018.
