I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Jaharlal Soren S/O- Jhargal Soren of Village- Kultar, P.O- Kutni, P.S.- Boro, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.
