Sir,

In producing here with arrested accused namely Piru Bouri (52 Yrs) s/o Lt. Bharat Bouri of Vill- Ladhurka (Bouripara) PO- Ladhurka, PS Hura, Dist. Purulia along with seized Country Spirit bottles DILSE (details of seized articles are mentioned in attached seizure list), I beg to submit that today on 15/07/2018 at 18.05 hrs received a credible source information I SI Swapan Majumdar along with force held raid (18.45 hrs.- 19.15 hrs) in the house of above noted accused person at Ladhurka (Bouripara) under Hura PS against illegal stock and selling of liquor and during the time of raid found that the above noted accused person was stocking and selling country spirit which was kept in his house at Ladhurka (Bouripara) under Hura PS, Dist Purulia, On demand, he failed to produce any valid documents/ License in respect of selling and stocking Country Spirit. Accordingly, I arrested him after preparing proper arrest memo, maintained all formalities regarding arrest as he committed offence U/S 46A(C) B.E. Act and supplied one copy to him. Then, I seized all the sealed Country Spirit bottles (details in attached seizure list) after preparing proper seizure list duly signed by the witnesses and labeled sample ~~two~~ bottles. This is to note here that on seeing police party all public/customers fled away. Total 32 (thirty two) bottles country spirit (DILSE 20 bottles), measuring 375 ML each bottle and value Rs. 22 each and 12 (Twelve) bottle country spirit (DIL KHUS) measuring 600 ML each bottle and value Rs. 35 each have been seized

Under the above circumstances and fact, I therefore pray that a Cog. Case U/S 46A(C) B.E Act may kindly be started against the arrested accused person namely Piru Bouri (52 Yrs) s/o Lt. Bharat Bouri of Vill- Ladhurka (Bouripara) PO- Ladhurka, PS Hura, Dist. Purulia and arrange for its investigation.
