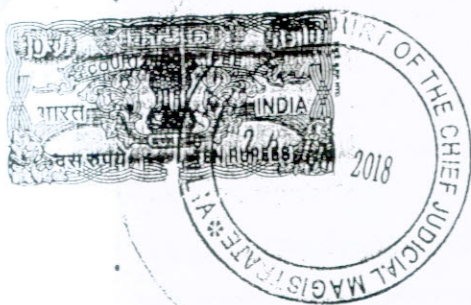

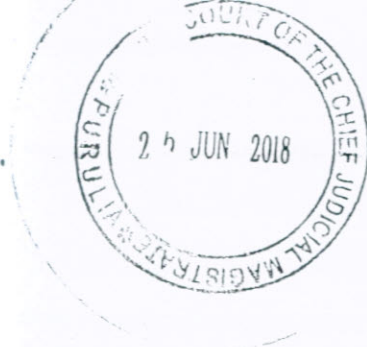
Most respectfully begs to state:-

- 4. That the complainant being the owner of the premises used to reside there but the above named persons suddenly come to the premises on 09.05.2018 with weapons in their hands and started to abuse the complainant and her other family members in filthy languages and threatened them of dire consequences unless they will not be given possession of the premises or to execute bond for deliver the possession of the premises, and on deny the above named wrongdoers assaulted the undersigned and threatened her to commit murder and also threatened to take forcible possession of the premises and at the time of leaving they stolen away certain household articles such as utensils, silver ornaments etc. from the house.
- 5. That the matter was duly intimated to Jhalda P.S, but they refused to take any action.
- 6. That thereafter seeing no other alternative the matter had been reported to the S.P. Purulia, on 04/06/2018, but no positive response from his end. Hence this petition.

It is therefore prayed that your Honour will be graciously pleased to send this petition to O/C Jhalda P.S. to treat this petition as an FIR as contemplated u/s 156(3) Cr. P.C. and to start a case in accordance with law and to unearth the wrong doers so that they can face their trial in the court of law.
