and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(I)(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Electric Fan - 03 nos.
- 2) Freeze - 01 no.
- 3) Color Tv - 01 no.
- 4) Tube Light - 02 nos.
- 5) CFL - 02 nos.

Out of which I seized the following.

PVC 2 Core Cable 3mts (Approx) alongwith Bypass wire.

Seizure list was prepared at the site and accused person refuse to sign/~~signed~~. The inspection team left the premises at 12:40 PM on 03/07/18. The accused person has committed an offence U/S135(I)(b) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.
